City Council Brief for June 21, 2023:

At the City Council meeting, the board took the following action on the agenda:

**Finance** – Received a presentation from HCT Certified Public Accountants and Consultants, LLC (HCT) pertaining to the City's Audit for Fiscal Year 2021 – 2022. **(Citywide)** 

**Human Resources** – Approved Resolution 77-23 creating and adding the position of Building Permit Records Clerk to the job classification list, increasing the authorized complement of budgeted positions for Development Services by adding four additional positions in the amount of \$60,000. **(Citywide)** 

**Library** – Approved Resolution 86-23 accepting the FY 2022 – 2023 State Aide to Libraries Grant Funds from the State Library and Information Services Division of FL in the amount of \$19,078. **(Citywide)** 

**City Administration** – Approved Resolution 87-23 authorizing the agreement for operation of Business Incubators between the City of Riviera Beach, the Riviera Beach Community Redevelopment Agency, and FoundCare, Inc.; providing for the CRA to operate and manage the City's business incubator space. **(District 2)** 

**Legal** – Approved Resolution 92-23 authorizing the agreement for Professional Services between the City of Riviera Beach and Angelia Gamble to provide legal support Services in the area of litigation, and claims in the amount not to exceed \$84,000.

**Development Services** – Approved Resolution 85-23 awarding an end-user professional services agreement to C.A.P. Government, Inc. (CAP) to provide building inspection, plan review, and permit technician services by piggybacking Palm Beach County Contract No. 22-080/LI on an asneeded basis as required in the amount of \$25,000. **(Citywide)** 

Approved Ordinance 4230 amending Chapter 31 of the code of ordinances entitled "zoning"; creating section 31-9, entitled Reasonable Accommodation procedures. (Citywide)

Denied Ordinance 4221 approving the application from Wantman Group, Inc. (WGI) requesting a zoning map amendment from an "RO" Recreation Open Space District designation to a "R-PUD" Residential Planned Unit Development District designation for an approximately 63.58-acre parcel of land formerly known as Lone Pine Golf Course. (**District 3**)
