IMMEDIATELY AND UNTIL FURTHER NOTICE BY THE UTILITY SPECIAL DISTRICT, A PRECAUTIONARY BOIL WATER NOTICE IS HEREBY ORDERED FOR ALL WATER USED FOR DRINKING, COOKING, MAKING ICE, BRUSHING TEETFI, OR WASHING DISHES. BEFORE USING YOUR WATER, PLEASE BRING IT TO A ROLLING BOIL FOR ONE MINUTE. AS AN ALTERNATIVE, BOTTLED WATER MAY BE USED.

TIES BOIL WATER NOTICE USUALLY STAYS IN EFFECT FOR A PERIOD OF 72 HOURS (3 DAYS) BUT MAY TAKE LONGER TO SATISIFY THE REQUIRED BACTERIOLOGICAL TESTING.

ONCE IT HAS BEEN DETERMINED BY A CERTIFIED LABORATORY THAT IT IS SAFE TO DRINK THE WATER, YOU WILL BE NOTIFIED BY THE UTILITY SPECIAL DISTRICT GIVING THE ALL CLEAR AND REMOVING THE BOIL WATER ORDER.
