

City of Riviera Beach Code Enforcement Division

Fine Settlement Application

Property owners who correct their outstanding code violations and bring their property into compliance with City codes and ordinances may be eligible to negotiate a settlement of fines for failure to comply with the terms of an order of the Special Magistrate.

ELIGIBILITY CRITERIA:

- Property must currently be in compliance with all City Codes and Ordinances.
- Property owner must not have active code enforcement violations on this or any property owned in the City of Riviera Beach.
- The property must not be subject to foreclosure action by the City of Riviera Beach or prior settlement agreement by the Special Magistrate or City of Riviera Beach City Council.
- Lot Maintenance, Boarding and Securing and Water and Sewer Liens are not eligible for settlement and must be paid in full.

TERMS OF FINE REDUCTION:

- Eligible property owners will pay 5% of the total fine as settlement for the outstanding fine owed to the City.*
- The City of Riviera Beach will issue a Satisfaction of Lien to the property owner after payment has been processed.
- \$75.00 non-refundable Administrative Fee is due at the time of submittal for each property.

*The City of Riviera Beach typically reduces fines to 5% of the outstanding fine amount; however, the City reserves the right in its sole discretion to seek more than 5% or less depending on the seriousness of the violation; the length of time and effort it took to obtain compliance; and the property owner's past history of code violations. The City also reserves the right to initiate foreclosure proceedings to collect the outstanding fine balance in lieu of reduction.

- Public Hearing Date and Location: All regularly scheduled hearings are held on the third Thursday of each month at 2:00pm in the City of Riviera Beach City Hall Council Chambers located at 600 West Blue Heron Blvd, Riviera Beach, FL.
- 10. Notice of Hearing: If the application is accepted, the applicant will receive a written Notice of Hearing, which will include the date time and the fine reduction request will be considered by the Special Magistrate
- 11. Presence at the Special Magistrate Meeting: The applicant or his/her representative may be present to anwer any questions concerning the request. If there are extenuating circumstances why the applicant or his/her representative cannot attend, please notify this office in writing prior to the meeting.
- 12. Preparing for Special Magistrate Meeting: It is the applicant's responsibility to research and know all laws that may be applicable and may affect the outcome of any decision on the applicant's request.
- 13. Exhibits at the Special Magistrate Meeting: If photographs, documents, maps or other materials are provided to the Special Magistrate as evidence at the hearing, the applicant must provide a copy to the Code Enforcement Division for examination. A minimum of three (three) copies of any exhibits and or evidence shall be provided. By law those instruments automatically become part of the public record and cannot be returned to the applicant
- 14. Payment of Settlement: The Code Enforcement Division will not accept payment until after the Special Magistrate has ruled in favor of the requested settlement offer. Payment must be in cash or certified check made payable to: City of Riviera Beach
- 15. The Sastisfaction of Lien: is prepared by the City of Riviera Beach, Office of the City Clerk, not the Code Enforcement Division. Please contact the Office of the City Clerk at (561) 845-4091 to make arrangements to pick up your satisfaction of lien.
