BOIL WATER NOTICE

TO: CITY OF RIVIERA BEACH RESIDENTS LIVING IN THE ADDRESSES NOTED BELOW,

DUE TO: Contractor Tie-In to Main Line

WEDNESDAY, SEPTEMBER 25, 2019 @ 9:00AM - 1:00PM

IMMEDIATELY AND UNTIL FURTHER NOTICE BY THE UTILITY SPECIAL DISTRICT, A PRECAUTIONARY BOIL WATER NOTICE IS HEREBY ORDERED FOR ALL WATER USED FOR DRINKING, COOKING, MAKING ICE, BRUSHING TEETH, OR WASHING DISHES. BEFORE USING YOUR WATER, PLEASE BRING IT TO A ROLLING BOIL FOR ONE MINUTE. AS AN ALTERNATIVE, BOTTLED WATER MAY BE USED.

THIS BOIL WATER NOTICE USUALLY STAYS IN EFFECT FOR A PERIOD OF 72 HOURS (3 DAYS) BUT MAY TAKE LONGER TO SATISFY THE REQUIRED BACTERIOLOGICAL TESTING.

ONCE IT HAS BEEN DETERMINED BY A CERTIFIED LABORATORY THAT IT IS SAFE TO DRINK THE WATER, YOU WILL BE NOTIFIED BY THE UTILITY SPECIAL DISTRICT GIVING THE ALL CLEAR AND REMOVING THE BOIL WATER ORDER.
